VFS will not assume any responsibility or liability for incomplete Visa Forms and/or incomplete supporting documents or inadequate Visa Forms forwarded by the Applicant to the DVPC.
- 6. VFS will accept no responsibility for late, lost or misplaced applications and/or the veracity of the contents of the same. Incomplete and double applications will be disregarded. - 8. Issuance of a visa or approval of visa application does not in any way give the applicant a right to enter UAE or Dubai. The entry is at the sole discretion of the Immigration Officer at Dubai Airport who is a representative of the Government of Dubai. - 14. All Indian and UAE Government regulations apply and in case this facility is deemed invalid or cancelled due to any Indian / UAE or any other Government regulation or order, VFS or EK will not be held liable for any compensation or claim by the applicants.
- 15. No refund of Visa Fees will be issued due to rejection of visa by the Government of Dubai, or due to cancellation or inability of applicant(s) to travel.
- 16. Applicants will be solely responsible to ensure they fulfil all Indian and UAE Government requirements for travel which may include getting "Emigration Check Required" clearances, Police clearances etc.
- 17. VFS will take all reasonable measures to ensure that information provided by the Applicants to VFS will remain confidential and protected from unauthorised access but VFS does not warrant against unauthorised access and will not be liable for any unauthorised access by any means to that information.
- 18. VFS reserves the right to add to, alter or vary these terms and conditions at any time without notice or liability, and all applicants availing of this facility shall be bound by the same.
